If the TN petition is approved but the change of status to/or extension of TN nonimmigrant status cannot be granted, you are still eligible to apply for the TN nonimmigrant status by visiting the US Consulate/Embassy office in Mexico. Indicate the US Consulate/Embassy location where you wish to have USCIS send the verification of your TN petition approval, via the Petition Information Management System (PIMS).
